(a) This document shows the infrastructure revenue and expenditure information 01 July 2023 to 30 June 2024.

(b) This document shows infrastructure charges information in accordance with Schedule 22 of the Planning Regulation 2017.

(c) Under the Planning Act 2016, infrastructure charges revenue that is collected in monetary form is not required to be spent in the same suburb or locality where it was collected.

(d) Offset provisions under the *Planning Act 2016* allow for an entire infrastructure charge, relating to more than one network, to be applied against the cost of infrastructure to be

provided under a condition of development (i.e. the construction of an arterial road).

(e) Infrastructure charges are collected in monetary form and in non-cash form as trunk infrastructure provided by a developer in lieu of paying the levied infrastructure charge (i.e. offsets).
